1. A Class A Membership Certificate must be owned by all Family and Single golfing members. New members may pay for their Class A Membership Certificate in one payment of \$400.00, or \$100.00 the first year and \$120.00 per year for three additional years (\$460.00 total payment). Associate and Junior members are not required to own stock.
2. Class B Membership Certificates are optional and cost \$500.00 per share. Holders are entitled to a discount on their membership dues equal to \$10.00 per share annually for each share owned.
3. Social members are required to own a Social Certificate which costs \$50.00 and includes their Social dues for one year.
4. This contract runs from 11/1/24 to 10/31/25, but will automatically renew each year for an additional one year term unless New Ulm Country Club receives written notice to the contrary from the Member no later than November 1<sup>st</sup> of each year. **By signing this agreement you become obligated to pay for a full year's membership and other services selected by you above on a monthly basis in the amount specified in this agreement.**
5. **You may terminate your membership for any reason at any time. However, if you do so, you are still obligated to pay the total monthly payment contracted for through the next October after the date of termination.**
6. By signing this agreement, you agree:
  - a) to pay all four annual installments for your Class A Membership Certificate, if applicable.
  - b) to pay all charges on your account with the New Ulm Country Club by the due date or pay a monthly finance charge equal to 1.8%.
  - c) to pay all costs of collection incurred by the New Ulm Country Club on any past due accounts, including reasonable attorney's fees.
  - d) that New Ulm Country Club may make annual adjustments to the annual membership and/or service rates set forth above and to accept such modifications effective November 1<sup>st</sup> of each year. Current rates are available at the clubhouse and members will be notified of any rate change prior to November 1<sup>st</sup> of each year.
  - e) to abide by all rules of the New Ulm Country Club.
