New members may pay for their Class A Membership Certificate in one payment of \$400.00, or \$100.00 the first year and \$120.00 per year for three additional years (\$460.00 total payment). Class A Stock is refundable by New Ulm Country Club if membership is terminated.
- 2. Class B Membership Certificates are optional and cost \$500.00 each. Holders are entitled to a discount on their membership dues equal to \$20.00 for each Class B Membership Certificate owned.
- 3. Social members are required to own a Social Certificate which costs \$50.00 and includes their Social dues for one year.
- 4. By signing this application, you agree to:
 - a) Pay all monthly payments of your membership dues, if applicable.
 - b) Pay all four annual installments for your Class A Membership Certificate, if applicable.
 - c) Pay all charges on your account with the New Ulm Country Club by the due date or pay a monthly finance charge equal to 1.8%.
 - d) Abide by all rules of New Ulm Country Club.
